- Braided RFP almost ready to be released.
 - Likely release in November
 - Ryan White and MAI service categories will start funding in 2025 to give agencies a year for planning close out and start up.
 - Because Ryan White is so administratively heavy, we want time to work with any new agencies in our network to have training to understand all requirements
 - If a currently funded agency is not selected, we want to provide plenty of time for them to create their transition plan
- Program Managers in Office of HIV Care are scheduling site visits with sub-recipients for November and December.
- Budget and invoicing workshop had almost 50 attendees receiving TA on how to develop a budget and connect it to their scope of work.
- Our 2024-2025 Non-Competing Continuation report was submitted 10/2/2023 Thank you PC staff and PC Co-Chairs for getting the necessary documents signed so we could submit on time.
- Of clients served during the reporting period (Q2) 89% are retained in care and 86% are virally suppressed
- The first quarter with housing status collected is reported below. 4 agencies out of 23 agencies responded to our pilot reporting request.
