C. Public Comment for Agendized Items

The conversation transitioned to the update regarding outreach materials approved by PLWHA and the swag they want to order for the Town Hall event in October. Additionally, staff reminded PLWHA the outreach letter was finalized in English and Spanish and to reach out to a Planning Council member to assist potential Spanish speaking members once the letter is implemented.

In addition, Bryan will ask the Membership and PPAC member, Angel, if he will assist Spanish speaking candidates for the remainder of this year. Staff updated the members regarding the Priority Setting process that was changed and discussed during the PPAC meeting on August 1st. The ballot was moved from paper to electronic ensuring a seamless process. Further discussion took place about the members' frustrations and concerns of the new process.
